Assistant Professor Position: Expertise is sought in Macro Practice, with a particular emphasis in Community Practice. An optimal candidate will have the ability to teach Macro Practice (Administration, Community Development, Social Policy) and will have demonstrated research expertise regarding community practice. Teaching experience at the undergraduate and graduate levels is desired. A candidate must show promise in obtaining extra-mural funds. An MSW and a doctorate in social work or a related field is required. A commitment to working in a multi-cultural environment with students from diverse backgrounds is desired. The SDSU School of Social Work is located near the Mexican border and in a large metropolitan area with a wide range of diverse communities which include newly arrived immigrants and refugees from many countries and centuries-old Native American tribes and bands. A candidate must have the ability to develop working relationships with local communities in order to conduct research which meets local needs and contributes to the scholarly literature on community practice.
