Partnering with Black Mental Health Providers to Support Assessment and Evaluation of Practice

Black Americans have similar rates of mental health challenges but are far less likely to access services when needed. This inequity is in part due to a lack culturally responsive mental health services, including a shortage of diverse racial/ethnic providers. To bridge this gap, this study will use human-centered design methods to partner with Black mental health professions to assess their needs for assessment and evaluation in their practice, to understand successful strategies and barriers to conducting assessments and evaluations, and co-create programming, tools and/or services to support their practice-based needs.
