# Introduction

Judicial races are some of the most important elections to participate in, but are often under-promoted and neglected by the public. Judges serve for some of the longest periods of all time out of elected representatives. some even serving for life. Judges on the Court of Common Pleas Pennsylvania serve for 10 years before running for re-election. While judges are meant to remain impartial when making decisions, interpretation of law can leave room for opinions or biases to be expressed, meaning judges have significant power over communities that are often overlooked.

This guide was created students at the University of Pittsburgh School of Social Work to educate the community on judicial candidates running in the 2025 primary on May 20th. We connected their platforms to social work values and emphasized themes of dignity, equity, and respect. Our hope is that this guide can help inform decisions when voting for 8 candidates this May.
