The **BSC / MT** will be responsible for providing therapeutic and behavioral consultative support to identified and authorized clients up to age 21 in the BHRS system. Responsibilities include, but are not limited to:

- Works with members of the treatment team
- Design and direct the implementation of behavior modification interventions
- Develop and provide oversight of the treatment plan
- Provide face-to-face services with identified client with exception of planning time to develop or update the treatment plan and program planning
- Prepare attendance and facilitation of the interagency team meeting
- Develop separate behavioral plans for each client to implement in various settings
- Responsible for coordinating services with collateral contacts involved with client
- Work closely with evaluators and CCBHO case manager to ensure consistent, timely and medical necessity level of care

1. Master's degree in human services field and documented training or experience in the field of behavior modification and at least one year experience in a CASSP related system
2. Working knowledge of Applied Behavioral Analysis
3. Knowledge of reporting child abuse
4. Excellent computer, organizational and customer service skills
5. Act 33 and Act 34 clearance and FBI background check, if applicable
6. Valid PA Driver's License
7. Must be 18 years of age
